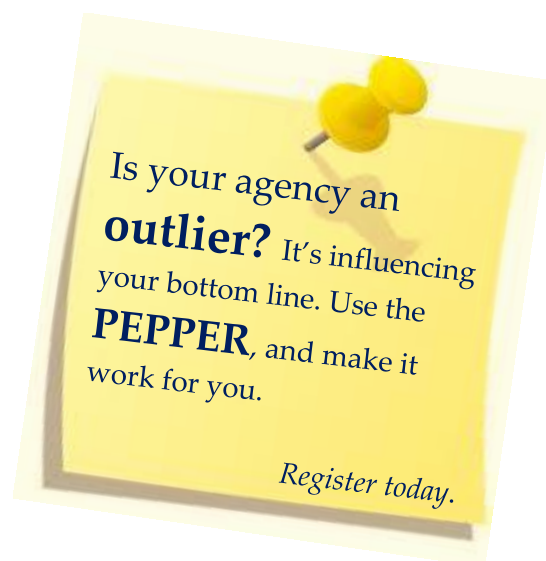

The PEPPER is a free report summarizing three years of an HHA's Medicare billing practices, comparing them with other HHAs for six areas at risk for improper Medicare payments. Are your agency's statistics at or above the 80th percentile and so identified as an "outlier" and seen as a risk for improper Medicare payments?
