**Webinar Description:** Pain is often a huge hurdle for clinicians to jump as they care for patients and if not controlled, pain has the power to significantly impact a patients' journey. Pain is a multi-faceted, multi-dimension, individual experience for our patients and as we sit across from them at the kitchen table, we need to have plenty of tools in our tool belt. This webinar will explore pain and what it means for our patients, barriers to its treatment, pharmacological and integrative approaches, as well as alternate routes.

- Discuss and assess the 4 domains of pain
- Describe 3 different pharmacological treatment options for pain and 2 integrative interventions
- Define the difference between physical dependence, tolerance, and addiction
- Explore rationale for use of 2 alternate routes for pain medication administration

**Angie Oujiri, MAN, RN,** is the Clinical Practice Leader at Fairview Home Care and Hospice and manages the Palliative Care at Home program which supports home care patients who need an extra focus on symptom management and end-of-life concerns.
